LOCATION

This farm and feed yard facility is located off U.S. Highway 70 in the fertile Upper Gila Valley of Graham County, Arizona, 10 miles west of Safford, approximately 165 miles east of Phoenix.

LEGAL

A portion of Section 31, Township 5 South, Range 24 East, G&SRB&M, Graham County, Arizona.

IRRIGATION

The farm receives gravity flow water from the Gila River by its inclusion within the Gila Valley Irrigation District ("GVID"). Additionally, the farm receives water from five farm-owned irrigation wells. District irrigation water is delivered from the Dodge-Nevada Canal at a cost of \$40.00/acre. Water rights to the Gila River are governed by the Globe Equity Decree. Recent claims and subsequent settlement affect the right and utilization of groundwater and surface water for the GVID. Decreed acres are allotted at six af/acre.

SOILS
